Extreme weather conditions and flooding can damage infrastructure, leading to outages caused by power disruptions. This incurs costs for CelcomDigi and impacts the revenue line. For example, during the 2015 East Coast flooding event, the estimated daily revenue impact was around RM500,000. The recent flooding event also resulted in costs to restore the network. Additionally, there are costs associated with preventive measures, such as raised infrastructure.
